Course Objectives: This course is the second part of the calculus sequence. In Calculus I, you

were introduced to the three fundamental notions upon which calculus is built: limits, derivatives and integrals. Our main objectives this semester are: (1) to deepen the comprehension of these notions through conceptual discussions and the investigation of many problems and applications; (2) to master more advanced methods and techniques, and apply them to the

solution of a variety of problems.

Assignments: There will be an in-class assignment almost every other class period,

which you are to work on during class time. You are encouraged to work in groups on these assignments. You do not need to turn these in; they are for your own benefit. In addition, homework assignments will be given at the start of each new chapter. There will be a quiz once every week that will be either taken directly from the homework assignments or very similar to them. You may not use your book during the quizzes, but you may use your homework, so it is definitely to your advantage to attempt all the problems on the homework assignments on your own. The lowest

two quiz scores will be dropped.

Assessment: Your overall grade will consist of the weighted average of your scores on

the exams, homework guizzes, and the final exam.
